- 1) Welcome/Introductions Everyone went around the table and introduced themselves and Lindsay took the lead in starting the meeting.
- 2) MVTPC Update
- a) What is Tech Prep?
- b) Benefits of Tech Prep include helping students determine what major or career field they wish to pursue through exposure to different options
 - Review of TP scholarships: Just a reminder that Sinclair Tech Prep scholarship recipients may use their scholarship dollars to pursue any degree or certificate program at Sinclair. Students may take classes at any Sinclair location or online and use their scholarship award money.
 - Review of college credit options including CTAG and PR. Jess sent out pdf file of breakdown of how courses appear on unofficial and official transcripts to teachers who attended Summit. Please see it following the minutes/PPT slides.
 - 3) BOGO '17 grads and '18 grads
 - a. This year the BOGO offer is for both 2018 Tech Prep grads and 2017 Tech Prep grads. Details about the BOGO offer may be found here:

 - 4) Summer Bridge contact: Mary Rospert <u>mary.rospert@sinclair.edu</u>
 - a. Summer Bridge is like an intensive orientation for students planning to attend Sinclair. The program gives students a leg up before starting college.
 - b. Tech Prep has Summer Bridge seats available. There is a cap of available seats for Tech Prep students. If we reach that cap I would call the students who registered past the capacity and let them know they would be placed on a waiting list.
 - 5) Onsite advising: MVCTC and KFHS participated and the teachers who represent those schools shared that they thought it went really well and that the students benefitted from the services
 - 6) Roles and relationships: Review PPT slide not a comprehensive list.
- 3) Update from Rex Mt. Castle for CIS 1350. The textbook is no longer a Sinclair-specific book and will not change next year. Tech Prep IT teachers who want a copy of the book should contact Pearson for an instructor copy or the TP office for a student copy. The software used to teach CIS 1350 is typically Aptana or Adobe Brackets, and server space is available to teachers at TP member schools via Sinclair if needed.
- 4) Eric Renegar & Kyle Jones provided an update of the CIS department and encouraged IT teachers to contact them directly with any questions or concerns: eric.renegar@sinclair.edu and kyle.jones4990@sinclair.edu.
 - a. AT&T Hackathon will be staged in the future under a new format, and a Sinclair-hosted event is TBD. Mark Romito (AT&T) has provided \$5,000 so that Sinclair can

- stage it again in 2019, but a 3rd party will facilitate the event. Time frame should be the same as previous events in 2018 and 2017.
- b. There are two new Data Analytics Associate's degrees that will roll out in fall 2018.

- c. CIS department is running about 10 grants right now. One is with the NSF and will most likely lead to Sinclair developing free, downloadable curriculum and resources for IT programs. Stay tuned for more information.
- d. UC agreements > 4 year completion options: Kyle has been working closely with UC on these and it has been a 2-year process. Computer Science (engineering) vs. Computer Info Systems Sinclair will be developing CS (engineering) curriculum for those who wish to transfer to a 4-year completion program. Higher-level math req. will be reintroduced to these new CS programs. Recently most had been removed from Sinclair CIS curriculum.
- e. Many Sinclair students transfer to WSU for 4-year completion. UD-Sinclair Academy degree option is in development with 30 hours in CIS to be taken at Sinclair and then the student will transfer to UD for work study and free courses at UD via UDRI projects. Kevin Klawon will visit HS classrooms and speak to students about UDRI: https://www.udri.udayton.edu/Pages/home.aspx. Teachers should contact Eric Renegar if they are interested in inviting Kevin to present.
- 5) Credit capture: Tim Bryant covered end of the year credit capture procedure re: PR courses (via eLearn). Contact Tim with any questions or concerns. New teachers who wish to offer PR credit options with students must complete a Non-Employee Network Account form to access eLearn. Josiah Wahlrab spoke about the TP Caspio portal and did a demo. For instructions regarding eLearn credit capture Josiah showed a YouTube video that will be posted to the TP web site soon. He also spoke briefly about MM3. Details related to MM3 can be found here: http://www.mvtechprep.org/index.cfm/resources/college-readiness.
- 6) Career Days: Teachers liked format from fall 2017. CIS may do 3 rotations w/shorter times with Sinclair CIS faculty for next year (3 rotations instead of 2). TBD, and Lindsay will organize IT days for fall of 2018 with the help of Eric Renegar before going on maternity leave to return in November.
- 7) College Transition
 - a. **GRFC 2018**: There was good feedback overall. Kyle and Eric received lots of activity at the CIS table and shared that the students who visited asked great questions.
 - b. University Transfer opportunities: Students who matriculate to Sinclair have many opportunities to continue on to complete bachelor's degrees at four-year colleges and universities that have articulation/transfer agreements with Sinclair. Detailed information about these opportunities may be found here:

For those students particularly interested in completing at Wright State or UD, there are additional web sites available detailing programs of study and special incentives for transfer students. c. Sinclair application: Any students who completed the Sinclair Tech Prep application fall 2016 and plan to attend Sinclair summer of 2018 or fall of 2018 may need to reapply to Sinclair by following this link: https://apply.sinclair.edu/standard.cfm. Teachers should reach out to Josiah Wahlrab for information related to determining if their students need to reapply. This year should be the last year that students need to take action in reactivating their Sinclair accounts.

Tech Prep Checklist: this replaced the prior years' tri-folds. They were distributed to schools earlier this semester.

Scholarship packets: Partner schools will receive their scholarship packets by dates requested to the MVTPC office. This typically happens in late April and continues through May. Need MM3 and CTE data to complete. Jammie Schneider will be gathering graduation information to identify when schools need packets.

CTAG Credit and Sinclair Transcripts

EXAMPLE 1: Student has CTAG credit ONLY posted to a Sinclair transcript, but does not matriculate to Sinclair

This illustrates the following scenario: A CTE student has his/her high school/CTC send a Medical Terminology CTAG verification form to Sinclair, but no other credit (i.e., AA, PR, CCP, etc.) has been posted to the student's transcript. Two semester hours' worth of TRANSFER credit "CR" for **HIM 1101** is posted and the student's account summary reflects this credit earned, but it is not institutional credit; it is TRANSFER credit. This information is visible only to internal student services folks who can access the XSCL – Student Information Summary screen in Colleague, as well as the XRCL - Transcript Course Listing screen. According to Assistant Registrar, Tammy Tolle, if this student orders an official Sinclair transcript in an attempt to transfer his/her Medical Terminology credit to another college or university, his/her request will be denied because there is no INSTITUTIONAL credit posted on the student's transcript, and therefore the student does not have an official transcript in the eyes of Sinclair.

Hi Jess,

I have attached 2 examples of how proficiency credits vs. Career-Technical Credit would post to an official transcript. All Career-Technical Credits Transfer (CT)2 verification forms are posted as external transfer credits and awarded the approved equivalent Sinclair courses based on the CTAG (Career Technical Assurance Guide) reporting system. The Career-Technical Credits Transfer (CT)2 are not posted as institutional credits as this program is guaranteed to transfer to a colleges/university based on the CTAG reporting system. Students do have to check to see where their approved courses will transfer within Ohio by checking CTAG. As noted in the attached examples, Career-Technical Credits are posted under TRANSFER CREDITS on the official transcript. The transcript only list the transfer institution name and how many hours Sinclair awarded to use towards a student's program of study.

Please be advised a student will not have an official transcript if a student only receives Career-Technical Credits and does not earn any Sinclair credits or proficiency credits. Students have to send their verification form to each institution they plan to attend as it is considered the official transcript for Career-Technical Credit.

Students who earn Sinclair proficiency credit by taking an exam will earn institutional credit and will post to the official transcript with a letter grade followed by a hash sign (#) or as AA (Articulated Agreement).

CTAG Credit and Sinclair Transcripts

EXAMPLE 2: Student has CTAG credit, PR credit, and AA credit posted to a Sinclair transcript, but does <u>not</u> matriculate to Sinclair

This illustrates the following scenario: A CTE student has earned AA credit for ALH 1130, PR credit for MAT 1270, and TRANSFER credit for HIM 1101, but does not matriculate to Sinclair. The student orders an official Sinclair transcript and MAT 1270 appears as a letter grade + hash tag (C#), the ALH 1130 appears as AA credit (no impact to student's GPA), and the HIM 1101 credit is listed Career Technical TRANSFER Credit, but the transcript does not indicate that the TRANSFER credit is for HIM 1101. It only indicates that the transfer credit is worth 2 semester hours and was posted in 2016. Again, assuming that the student has ordered a transcript to try and use his/her credits at another college or university, s/he will discover that s/he must have his/her high school or CTC resend the CTAG verification form to the institution where s/he wishes to attend, AND that college or university must offer a course equivalent for it to benefit the student.

EXAMPLE 3: Student has CTAG credit and PR credit posted to a Sinclair transcript, and matriculates to Sinclair pursuing a degree that truly enables him/her to take advantage of some (or all) of the credits he earned in high school

This illustrates the *best* case scenario for a student who has earned CTAG credit, has matriculated to Sinclair, and has enrolled in a degree program or certificate that allows him/her to apply the credit toward a certificate or degree. His/her official transcript reflects both institutional and transfer credit earned, as well as institutional credit that is "IP" or in progress. The six hours of CIS credit earned by way of CTAG equivalent transfer credit is still identified as Career Technical TRANSER Credit, but if you look at the student's attached "Academic Evaluation" (otherwise known as a degree audit), you will see that those credits have been applied as "TE" or Transfer Equivalency courses within the sixteen-hour block of Sinclair CIS courses required for the degree. So long as the student sees the degree through completion, those credits will count toward the required sixty-three hours of semester-based credit required for the Associate of Science in Cyber Investigation Technology.
