Official Announcement: Multiple Measures (MM3) Policy to be Permanent

Based on the success of the pilot years using multiple measures to determine college readiness, Sinclair will be putting in place a permanent policy for MM3. The pilot was designed to eliminate the requirement for students to take the college readiness assessment if students demonstrated college readiness through one of many measures, including their cumulative high school GPA. Tech Prep students are automatically considered for MM3, but the general non-Tech Prep population may also utilize this policy, providing an official high school transcript to Academic Advising for review.

Multiple Measures 3.0 GPA Guidelines

Tech Prep students will be eligible to take ENG 1101 and MAT 1110, 1120, 1125, 1130, or 0200 in any one of the following circumstances:

Tech Prep students must have a high school GPA of 3.0 or better at the end of the first semester of their senior year. (The GPA is calculated based on academic and career tech coursework completed junior year and the first semester of senior year.) This measure is consistent with the current process MVTPC has used for many years to collect scholarship data on the senior transmittal form.

Using the Miami Valley Tech Prep portal, designated high school administrators submit the student's seventh semester GPA. Deadline for submitting the data for MM3 consideration is March 23 annually in order to enable eligible Tech Prep students to take advantage of enrolling (after high school graduation) at Sinclair in summer semester post-graduation and beyond.

Students who do not meet the 3.0 GPA requirement will have the following, additional options to be exempt from Sinclair's college readiness assessment and proceed directly into college level English and appropriate Math courses:

- 1. All students have the opportunity to be exempt from Sinclair's college readiness assessment for Math if they successfully complete MAT 1110, MAT 1120, and MAT 1130, or MAT 1125 proficiency exams provided by MVTPC through the current elearn process.
- 2. All students have additional opportunities to be exempt from Sinclair's college readiness assessment by completing another college entrance exam and meeting the required scores listed below:
 - To enroll in ENG 1101 at Sinclair College students must have an ACT English score of 18 or above OR an SAT English score of 430 or above.
 - To enroll in MAT 0200 at Sinclair College students must have an ACT Math score of 19 or above OR an SAT Math score of 460 or above.
 - To enroll in **MAT 1470 or 1580** at Sinclair College, students must have an ACT Math score of 22 or above OR an SAT Math score of 520 or above OR provide validation through an official transcript or supervisor validation in the Tech Prep portal that the student earned a B or better in an Algebra II.
 - To enroll in MAT 2270 at Sinclair College, students must have an ACT Math score of 27 or above OR SAT Math score of 620 or higher OR provide validation through an official transcript or supervisor validation in the Tech Prep portal that the student earned a B or better in Pre-Calculus

Please note: All ACT (submittal code 3332) and SAT (submittal code 1720) reports must be submitted to the New Student Enrollment Center in Dayton or to any Sinclair Regional location **by the student.**

When meeting with Academic Advising, it is also best for the student to bring a high school transcript.
